

Rating Action: Moody's assigns Baa2 to Pilot Knob MUD 3, TX's GOULT Bonds; stable outlook

New York, November 29, 2021 -- Moody's Investors Service has assigned Baa2 ratings to Pilot Knob Municipal Utility District 3, TX's \$6.5 million Unlimited Tax Bonds, Series 2021A and \$5 million Unlimited Tax Road Bonds, Series 2021. Moody's maintains the Baa2 rating on the district's general obligation unlimited tax (GOULT) bonds. The district's total GOULT debt outstanding will be \$38.4 million post-sale. The outlook is stable.

RATINGS RATIONALE

The Baa2 rating incorporates a small but rapidly growing residential tax base and a healthy financial position. The rating also incorporates a high debt burden that will remain elevated because of the significant amount of debt still owed to developers, and a lack of pension and other post-employment benefit liabilities.

RATING OUTLOOK

The stable outlook reflects the expectation that construction of single-family homes will drive assessed value (AV) growth over the next several years and that general and debt service fund reserves will remain sound. In addition, the district will only issue new debt in conjunction with AV growth, which will keep the debt burden stable but high.

- Continued tax base growth
- Material improvement in fund balance and liquidity
- Material decline in the debt burden

FACTORS THAT COULD LEAD TO A DOWNGRADE OF THE RATINGS

- Tax base contraction
- Decline in fund balance or liquidity
- Increase in the debt burden

LEGAL SECURITY

The bonds are secured by an annual ad valorem tax levied, without legal limit as to rate or amount, against all taxable property located within the district.

USE OF PROCEEDS

Proceeds of the Series 2021A bonds will reimburse the developer for water, wastewater and drainage improvements. Proceeds of the Series 2021 road bonds will reimburse the developer for road improvements and finance 18 months of capitalized interest.

PROFILE

Pilot Knob MUD 3 contains 678 acres and is located eight miles southeast of downtown Austin (Aa1 stable) in Travis County (Aaa stable). The estimated population is 3,120. Utility operations are provided by Austin.
